NEW BUSINESS

Adjudication Development Handbook & Procedures Adoption

- *Adoption will start at the beginning of the 2023-24 school year
- *A trail run option for Solo & Ensemble 2023 judges, at the discretion of the site/event host (it will not be required but encouraged). Trial run will give the opportunity for direct applied feedback

On behalf of the Adjudication Development Committee, Bob Borden makes the following motion: "I make a motion to implement the adjudication manual as part of all adjudicated events in SCMEA Orchestra Division." Angela Rex seconds the motion. Floor is open for discussion. Committee speaks to membership about the Adjudication Handbook and Procedures and the training process. If motion is passed, the committee would like to field test the procedures during S&E. With concerns of violating bylaws and work of current committees, Chris Selby moves a substitue motion to the standing motion with the following motion: "To approve the adjudication development handbook and procedures to be sent to the CPA, S&E, Region, and Allstate committees as recommendations for their respective committees to use at their discretion to determine how best to implement these recommendations in their respective events." Point of order called by Colleen Marcou. Parliamentarian clarifies that motions can be made within the standing motion. Audrey Bass 2nds motion. Floor is open for discussion. Clarification between to the two motions is asked. Both motions are reread. The committee's intent is for this handbook to help and enforce the respective committees and to help teachers across the state to be prepared for adjudicated events. Topics of discussion included the following: ensuring the division has qualified judges, equitability across regions, field testing handbook, opposition to adjudication committee, complaints within our adjudicated events and committee chairs not receiving said complaints, differing budgets and rubrics within adjudicated events, telling committees how to run their events, formal review process, adjudication handbook being active in bylaws or standing rules, and members wanting more to time before implementation. Point of order called by Jennifer Diehn on order of events. Parliamentarian clarifies motion has been substituted. Chad Hammer motions to end discussion. Susan Wines seconds the motion. Discussion closed. Parliamentarian reminds the membership call to vote will be on the substituted motion. Original motion and substitute motion are re-stated for the membership. Substitute motion called to vote. All in favor. Substitute motion passes.

Discussion of Executive Report

Starting in the 2023-24 school year, Allstate Auditions will charge \$10.00 registration fee, S&E solos will be \$10.00, and Allstate Conductor stipends will be raised to \$2,000.
